ORDER

General Conditions:-

- (i) Re-allotment requests, if any, shall not be entertained before completion of tenure as envisaged in Directorate letter No. 9-23/2014-SPG dated 25-02-2020.
- (ii) It is the responsibility of the officer to send a copy of the charge report through concerned Region/Division on assumption of charge on the promoted post to this office for information.
- (iii) Region/Division/Units are requested to relieve the officers immediately to enable them to join on their promotional post. In case, posting order from the

allotted circle is not received, the relieving circle shall relieve the promoted officer and ask the officer to report to the allotted circle headquarters.

(iv) In case of officer (s), who is not willing to accept his/her promotion, his/her declination letter in writing through proper channel should reach this office within 30 days of issue of Directorate order No. R-09/13/2025-SPG-II-DOP dated 30-12-2025. Non-assumption of charge within 30 days without valid reason will be treated as deemed declination of promotion.

VIGILANCE / DISCIPLINARY CASES, IF ANY :-

(a) If there is any vigilance/disciplinary case as referred to in DoP&T O.M. No. 22011/2/86-Estt.(A) dated 12.01.1988 issued by DoP&T circulated vide Directorate memo No. 25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DoP&T memo No.22022/4/91-Estt.(A) dated 14.09.1992 circulated vide Directorate Memo no. 25-19/88-SPG dated 13.10.1992 is pending against the officer / official, he/she should not be relieved for posting without obtaining specific order from this office. An intimation report in this regard may be reported immediately to this office.

(b) In this regard, the instructions issued by Personnel Division (SPN-II) section vide its letter No. X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024 must be strictly followed.

PROBATION PERIOD :-

The officer / officials who have been promoted to Postal Service Group 'B' will be on probation for two years and then their suitability to hold the post will be adjudged on completion of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation will be extended depending upon the period of leave.

TRAINING :-

The officials will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo prescribed training as and when notified by the Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.

OPTION FOR FIXATION OF PAY :-

The officers wishing to give option for choosing date for fixation of pay under FR-22(I)(a)(1) should do so within one month from the date of assumption of charge on promotion.

This is issued subject to the outcome of orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors Vs. Lachmi Narain Gupta and Ors [Civil appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011] and others connected matters.

Before assumption of charges, it must be ensured by controlling authority that the officers promoted on adhoc basis must be reverted to their substantive cadre.

Relevant charge reports may please sent to all concerned immediately.

All other terms and conditions contained in Directorate order No.R-09/13/2025-SPG-II-DOP dated 30.12.2025, corrigendum dated 31.12.2025 and letter No. A-34013/02/2023-DE dated 26.12.2025 shall remain unchanged and continue to apply.

Besides the above, I am directed to intimate that the allotment in respect of **Shri Sadashib Rout, IP, Baripada East Sub Division** issued vide Directorate

order No. R-09/13/2025-SPG-II-DOP dated 30.12.2025 following the declaration of the LDCE PS Group 'B' result held on 04.06.2023 communicated vide Directorate letter No. A-34013/02/2023-DE dated 26.12.2025 has not been effected by the Competent Authority due to the officer's disciplinary/vigilance status being 'Not Clear' as reported by the APMG (Vigilance), CO, Bhubaneswar vide letter No. Vig/8-Misc-6/2025 (Ch-I) dated 31.12.2025.
