Hence their period of participation in the 38th All India Postal Cultural Meet 2025-26 at Mysore, Karnataka from 16.02.2026 to 20.02.2026 including actual journey time will be treated as **On Duty** and they are entitled to draw TA & DA (entitled to travel by 3rd AC train only and entitled to draw DA @ Rs. 500 per day only for the above meet and journey period) as admissible under rule. All the concerned officials are requested to submit their TA/DA claim to this office through the Team Manager which will be borne from OCPSB fund. The GDS participants at Sl. No. 1 and 2 may be allowed leave for the above period as per the GDS rules applicable to them. TA/DA for the GDS participants at Sl. No. 1 and 2 will be borne from OCPSB fund.

Escorts at Sl. No. 4, 11, 12, 13 and 14 are parents of the junior/senior group participants. All escorts except Sl. No. 11 are employees of the department. Hence, the period of participation in All India Postal Cultural Meet 2025-26 at Mysore, Karnataka from 16.02.2026 to 20.02.2026 including actual journey time will be treated as On Duty and they are entitled to TA & DA as admissible under rule. They must submit their TA/DA claim at their respective offices.

Senior Participants at Sl. No. 3, 6, 9 and 10, for participation in 38th All India Postal Cultural Meet 2025-26, their TA/DA will be borne from OCPSB Fund.

In case of junior participants, escorts other than employees of the department (i.e., Sl. No. 11) will be paid TA/DA from OCPSB fund and maybe allowed leave for the period from 16.02.2026 to 20.02.2026 at Mysore, Karnataka as per GDS rules applicable to them.
