The officials so promoted to LSG (Postal) cadre on regular basis should join in their new place of posting within one month from the date of issue of posting order failing which it will be presumed that the official has declined the promotion. Declination, if any, submitted by the official should be forwarded to Circle Office, Bhubaneswar immediately after completion of requisite time period endorsing a copy to this Office.

This is regular promotion and as such the officials declining the same should be clearly made out that by doing so, they will not be eligible for any financial up-gradation under MACP Schemes.

The concerned Divisions will issue orders of place of postings of the officials allotted to their Divisions observing usual formalities.

The promotion is subject to the final outcome of SLP(C) No.30621/2011.
