**ORDER**

In pursuance of Directorate order No. R-09/13/2025-SPG-II-DOP dated 30.12.2025, office order No 09-01/2024-SPG-II dated 11.03.2026 and corrigendum of dated 13.03.2026, the Competent Authority is pleased to convey the approval of Director General Postal Service for promotion of the following Inspector Posts Line officer to Postal Service Group 'B' cadre on regular basis in Level-9 of Pay Matrix (7th CPC) (Rs 53,100-1,67,800) with effect from the date of assumption of charge of the post and until further orders.

Consequent upon allotment of officer to Odisha Circle, the Competent Authority is pleased to order Regional allotment on promotion to Postal Services Group 'B' to have immediate effect .

**General Conditions :-**

(i) Re-allotment requests, if any, shall not be entertained before completion of tenure as envisaged in Directorate letter No. 9-23/2014-SPG dated 25-02-2020.

(ii) It is the responsibility of the officer to send a copy of the charge report through concerned Region/Division on assumption of charge on the promoted post to this office for information.

(iii) Region/Division/Units are requested to relieve the officer immediately to enable him to join on their promotional post. In case, posting order from the allotted circle is not received, the relieving circle shall relieve the promoted officer and ask the officer to report to the allotted circle headquarters.

(iv) In case of officer (s), who is not willing to accept his/her promotion, his/her declination letter in writing through proper channel should reach this office within 30 days of issue of Directorate order No.

R-09/13/2025-SPG-II-DOP dated 30-12-2025. Non-assumption of charge within 30 days without valid reason will be treated as deemed declination of promotion.

**VIGILANCE / DISCIPLINARY CASES, IF ANY :-**

(a) If there is any vigilance/disciplinary case as referred to in DoP&T O.M. No. 22011/2/86-Estt.(A) dated 12.01.1988 issued by DoP&T circulated vide Directorate memo No. 25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DoP&T memo No.22022/4/91-Estt.(A) dated 14.09.1992 circulated vide Directorate Memo no. 25-19/88-SPG dated 13.10.1992 is pending against the official, the officer / official should not be relieved for posting without obtaining specific order from this office. An intimation report in this regard may be reported immediately to this office.

(b) In this regard, the instructions issued by Personnel Division (SPN-II) section vide its letter No. X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024 must be strictly followed.

**PROBATION PERIOD :-**

The officer who has been promoted to Postal Service Group 'B' will be on probation for two years and then his suitability to hold the post will be adjudged on completion of probation. If the officer proceeds on leave for a period exceeding 30 days during this period, the probation will be extended depending upon the period of leave.

**TRAINING :-**

The officer will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, he will have to undergo prescribed training as and when notified by the Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.

**OPTION FOR FIXATION OF PAY :-**

The officer wishing to give option for choosing date for fixation of pay under FR-22(I)(a)(1) should do so within one month from the date of assumption of charge on promotion.

This is issued subject to the outcome of orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors Vs. Lachmi Narain Gupta and Ors [ Civil appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011] and others connected matters.

All other terms and conditions contained in Directorate order No. R-09/13/2025-SPG-II-DOP dated 30.12.2025, corrigendum dated 31.12.2025 and letter No. A-34013/02/2023-DE dated 26.12.2025 shall remain unchanged and continue to apply.
