RMS Divisions, by performing their duties of transmission, accurate sorting, and secure dispatch of mail bags, play a vital role in ensuring that consignments move swiftly and correctly through the postal network. Similarly, Postmen, GDS, and BPMs at the final stage of delivery are requested to handle these consignments with

care, ensure secure and timely delivery to the recipient, and make proper remarks wherever required.

The successful execution of this arrangement will not only strengthen the trust of devotees in the Department of Posts but also enhance the reputation of our Speed Post services in handling sacred consignments with utmost care and reliability.

All Postal Divisions and RMS Divisions are requested to give **wide publicity to this letter** across all offices under their jurisdiction. Your cooperation and support in this matter will greatly contribute to the Department's commitment to service excellence and enhanced customer satisfaction.
